## 3. Meeting Minutes

Motion made by Mr. Creonte to approve the meeting minutes of October 17, 2023, seconded by Ms. Oliver Jerram. All in favor. Motion passed.

# A. Vote on CPA Allocations

- 1. Estimated City Surcharge for FY2024 (\$3.9M):
  - \$ 390,000 to Open Space Recreation (10%)
  - \$ 390,000 to Historical (10%)
  - \$ 390,000 to Housing (10%)
  - \$ 195,000 to Administrative (5%)
  - \$ 2,535,000 to Undesignated (65%)

Motion made by Ms. Oliver Jerram to approve the estimated city tax estimate of \$3.9M for FY2024. Motion seconded by Mr. Doyle. All in favor. Motion passed.

#### 2. CPA Unappropriated Balance from FY2023 (\$550,907.09)

Motion made by Mr. Doyle to approve the unappropriated balance of \$550,907.09 for FY2023 and move it to CPC's Undesignated account. Motion seconded by Mr. Doyle. All in favor. Motion passed.

# 3. State Match for FY2024 (\$780,352.00)

- \$ 78,035.20 to Open Space Recreation (10%)
- \$ 78,035.20 to Historical (10%)
- \$ 78,035.20 to Housing (10%)
- \$ 39,017.60 to Administrative (5%)
- \$ 507,228.80 to Undesignated (65%)

Motion made by Mr. Creonte to approve the State Match of \$780,352.00 for FY2024. Motion seconded by Ms. Oliver Jerram. All in favor. Motion passed.

## B. CPA Balances

Mr. Barrett gave an update on each of the CPC's account balances, as of November 15, 2023: Open Space (\$1,799,154.46), Historical (\$0), Housing (\$0), and Undesignated (\$5,545,569.45), for a total of \$7,344,723.91.
