DESCRIPTION OF OUTPUT STATEMENT:

During past fiscal years the commission has distributed funding to assist other city departments in providing or upgrading means of access into and out of public buildings and enhancing mobility within buildings. The commission has provided portable accessible toilets at various city events. The commission worked with the traffic department to install "countdown" signal lights at several intersections throughout the city. During the past year the commission has completed numerous projects- see services provided section.

STATEMENT OF OBJECTIVES:

To address ability issues throughout the year within the community. To maintain the ongoing close relationship with the staff the office of Handicap Affairs. To seek money from sources to affect the removal of barriers in the city. To provide assistance to access Municipal buildings. Have a minimum of 10 open meetings per year. Provide an educational forum for the community. To reevaluate all City of Waltham buildings to determine compliance with the Federal and state regulations. Review Accessibility Technology. Explorer need for accessibility equipment with in public buildings (i.e. Wheelchairs and). Investigate and evaluate types and amount of sensible Transportation within the City of Waltham

- \$15,000 for planning phase two of the ADA Transition Plan
- \$2,500 allocated to continue funding the HP portable toilets for city functions
- \$2,500 allocated to continue funding the HP portable toilets for city functions
- \$500 for new HP parking signs ordered by Traffic Dept.
- The DSC addressed these issues with Mike Garvin, a Waltham Traffic Engineer, in November. A letter was sent to the Traffic Dept. to advocate that this intersection be made a high priority. A request was also made for a "no turn on red" sign at Gore Street.
